Universal Health Coverage

Ensuring they everyone has access to needed healthcare is crucial for improving and maintaining human health. At the same time, people need to be protected from being pushed into poverty because of the cost of accessing the care they need. Universal Health Coverage is defined as ensuring that all people have access to high-quality health services that ensures the use of these services does not expose the user the financial hardship. GHPU is at the forefront of research to support policy action in pursuit of these objectives.

- Global focus on the social, economic and political processes which shape health and its determinants










Core Programme Concepts: Universal Health Coverage (UHC)

The WHO defines UHC as:

"All people have access to the health services they need, when and where they need them, without financial hardship. It includes the full range of essential health services, from health promotion to prevention, treatment, rehabilitation, and palliative care."







SDH, vulnerability, and policy

- Pre-pandemic: SDH associated with poor access to care and poorly controlled chronic (and other) diseases => greater vulnerability to complications of COVID-19.
- During the pandemic: SDH impacted access to treatment <u>for</u> Covid-19 AND vulnerability to mitigation measures.
- Currently: The economic impact of the pandemic means more people facing economic hardship, making them more vulnerable to disease including but not limited to Covid-19.

Highlighting the clear need for both UHC and equity in the forces that generate health

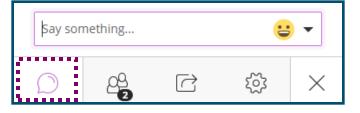



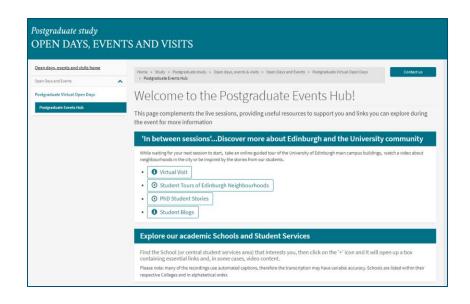
