Why study for an online PgCert, PgDip or MSc?

- Flexible learning environment be adapted to suit individual needs.
- Suited to students already in full- or part-time employment or with other professional or personal commitments.
- Become part of a supportive online community, bringing together students and tutors from around the world.





Who are the staff?

Usually:

- European Diplomats and/ or RCVS specialists
- Nationally and Internationally recognised experts in their field
- Active in clinical practice
- Experienced veterinary medical teachers





Online PG Cert / PG Dip / MSc / MVetSci (1-6 years)

- PG Certificate (Year 1-2 60 credits)
- PG Diploma (Year 2-3 or 3-4 60 credits)
- MSc (Year 3 or 4 or 5 or 6 60 credits)
- Short courses and Postgraduate Professional Development (up to 40 credits) options available.





Online PG Cert / PG Dip / MSc / MVetSci (1-6 years)

- Modular September to June each year
- Each year = 3 teaching blocks of 12 weeks
- Flexible and intermittent options





Online teaching

- Lectures Live and/or Recorded
- Tutorials
- Discussion boards
- "Live chats"
- Assessments
- Reading list







How will I be assessed?

- Range of methods appropriate to the course topic
- Usually two assessments per course
 - Case reports and critical reviews of scientific publication
 - Critical reviews
 - Learning diaries
 - Presentations
 - Multiple-choice questions
 - Short answer questions
- Dissertation research project or fully-taught route







Compulsory courses

- Basic Sciences in Veterinary Anaesthesia and Analgesia (20 credits)
- Clinical Anaesthesia: Equipment and the Patient (20 credits)







- Elective courses (Certificate and/or Diploma)
 - Dogs and cats
 - Ruminants, camelids and pigs
 - Equidae
 - Small mammals
 - Chronic pain and advanced analgesic principles
 - Ethics for veterinary clinicians and researchers
 - (Each course 10 credits)







Elective courses (Diploma only)

- Ventilators and Ventilation in Veterinary Anaesthesia
- Advanced cardiovascular procedures and monitoring
- Avian anaesthesia
- Non-technical skills for safer veterinary care
- Techniques & interventions for conservation medicine
- Assessment, measurement and the multi-disciplinary approach
- Professional skills and clinical skills for Advanced Veterinary Practice
- Evidence-Based Veterinary Medicine in Clinical Practice
- Research Methods and Data Analysis
- Non-pharmacological approach to pain management
- (Each course 10 credits)
- Veterinary musculoskeletal pain (20 credits)







- Dissertation year
- Choose from
 - Experimental study
 - Literature review
 - Clinical audit





- Select courses that meet individual professional needs.
- Courses across a range of species, e.g.
 - companion animals
 - exotic zoo and wildlife
 - equine
 - production animals







• **PGCert** - three compulsory modules (30 credits):

- Professional and Clinical Skills
- Evidence-Based Veterinary Medicine
- Standard Diagnostic Testing in....
- Plus a further choice of modules depending on your area of interest (30 credits)





PGDiploma – Elective courses:

- Wide range of courses
 - Equine, e.g. behaviour and welfare
 - Production Animal, e.g. feeding for production
 - Companion Animal, e.g. respiratory medicine
 - Exotics, e.g. rabbit medicine
 - Courses in behaviour, welfare, ethics, epidemiology, anaesthesia and analgesia across all species







MVetSci - choose:

- a written dissertation (60 credits)
- a short research project (20 credits) plus elective courses (40 credits)
- elective courses (60 credits)





RCVS Certificate in Advanced Clinical Practice (CertAVP)

- RCVS qualification
- Six 10-credit modules
- A-FAVP [foundations]
- B module [depending on area of interest]
- Three C modules [focus on area of interest]
- One final free-choice module [B or C level]
- Synoptic examination

Assessment only or taught [links to Advanced Clinical Practice]
