Summary of proposed potential new project licence amendment: this will consider whether the use

It was noted that discussions with the HOI for (where the licence has primary availability) have not raised any initial concerns.

Summary of required actions:

1. AWERB made aware of these new studies: completed 26/4/21
2. Discuss this possible study with our inspectors to gauge opinion, and clarify the requirement for an amendment. .
3. Noted that as the first study only plans to use 2 pigs, this would constitute a pilot study.
4. Background: the phenomenon of is documented and also published in the literature.
5. Isoflurane: regarding questions relating to the use of isoflurane and “safety” it was noted that while there are advantages with isoflurane no anaesthetic is completely safe.
6. to be made aware that the AWERB would advocate the addition of amended text to the PPL explaining that is being used for a different scientific purpose (rather than just).
7. Noted that AWERB has a duty of diligent ethical appraisal of all proposed scientific studies involving animals, regardless of whether the original PPL is held at or elsewhere.

presentation:

The project licence application also has additional availability at the , this has also been presented to their AWERB 20/4/2021.

Discussion points:

1. **Adverse effects study (Sedation):** Noted that as pigs can be sedated for prolonged periods, consideration should instead be given to the use of light anaesthesia to improve recovery time, and minimize administration steps.
2. **Infectious diseases:** currently not planning to look at any other diseases at the moment, only work is planned currently.

6. Project licence applications under consideration

PL10-21:

Summary of review points:

1. Some concerns with the inclusion of the work in ruminants. An amendment in the previous PPL covering such work was agreed last year at the start of the pandemic when the urgency of the situation, suggested there were clear potential benefits to expediting the proposed studies at the earliest opportunity. At the time the committee agreed that, in future, a separate licence to cover studies would be preferable.
2. **Funding:** clarify level of funding for all planned work.
3. **General structure:** The inclusion of the work makes the licence much more difficult to understand, this can also cause issues in relation to understanding and interpreting adverse effects.
4. **Numbers:** more justification for the increased numbers is required in the application.

Summary: approval subject to the proposed work being separated into a pig licence and a ruminant licence, with the latter focussing on work.
