Questions/Discussion:

- 1. Numbers: there was a large increase in numbers which the AWERB requested information and justification for. There was some discussion about whether this would warrant a new PPL however the PPL holder felt that it was appropriate to keep this under the current PPL.
- 2. Objectives: clarify whether the current objectives would cover this work as this seems to be expanded further than a pilot study.
- 3. Noted that this proposed work also relates to a currently granted amendment which will focus on the . The researcher who is collaborating with the PPL holder plans to continue work within .
- 4. Clarity required on whether there are plans for a bigger project?

17. Presentation: Nested refinement studies:

The committee heard a thought-provoking presentation aimed at raising awareness of whether the incorporation of "nested refinement studies" (NRS) could become a more routine consideration in planning experimental protocols conducted under Home Office approval.

An NRS, defined as clinical veterinary research conducted on animals otherwise protected under ASPA, would focus on refining technique towards best practice – with resultant animal welfare and scientific benefits.

However, currently the opportunities to improve on clinical practice can founder within the constraints of hypothesis-led experimental protocols that seek consistency in order to reduce variability.
