## 1. Introduction

This guide explains the process for making a PVG application online. It includes screenshots that show the processes for:

- someone joining the PVG scheme – required for all new applicants joining the scheme
- someone requiring an Existing Scheme Record – required for existing PVG members applying to work with a new vulnerable group
- someone requiring a Scheme Record Update – required for existing PVG members changing employer, or for employers requesting a record update


As a demonstration, some fields are already filled in the screenshots. However, all fields will be blank at the start of your application.

The online application process has two parts:

- Part 1 - to be completed by the CSG
- Part 2 - to be completed by you, as the applicant
