Disclaimer: This document was created and revised in January 2024. It is important to note that the application format and how questions are phrased can be altered or changed by the UKVI at any time. This document should only be used as a guide for understanding the application process, and it addresses any questions, which are frequently asked by our students applying for the Graduate route visa. Please be aware that the order of questions on the application form can change or new questions may be added by the UKVI in the future. If you notice anything significantly different on the application form, which is not in this guide then please inform us.

This guide is for the University of Edinburgh students who are completing their Graduate route visa application from inside the UK. You should apply once the University has notified UK Visas and Immigration (UKVI) of your eligibility for the Graduate route visa and we have sent you a reminder of what your last CAS number which you need for the application.

Are you ready to apply?

You should only apply for the Graduate route visa if:

- You have received email from the University confirming that your successful completion has been reported to UKVI. This email will also provide the CAS number you need to apply
- You are inside the UK
- You have a valid Student Visa at time of application
- You have checked you meet other eligibility or validity requirements <u>A Guide to the Graduate</u>

Please be aware that if you apply before successful completion has been reported to UKVI, your application could be refused.

You must apply online for a Graduate visa.

Check which documents you'll need to apply.

Your partner or children will need to apply separately.

Proving your identity and providing supporting documents

As part of your application, you'll need to prove your identity.

You usually do this by scanning your biometric residence permit (BRP) with the 'UK Immigration: ID Check' app. If you're from the EU, Switzerland, Norway, Iceland or Liechtenstein, scan your passport instead.

You'll need to sign into an existing UK Visas and Immigration (UKVI) account, or create a new one.

If you cannot scan your BRP or passport with the app, you'll be asked to get your fingerprints and photograph taken at a <u>UK Visa and Citizenship</u>
<u>Application Services (UKVCAS)</u> service point.

You'll be told what you need to do when you apply.

If you do need an appointment, the centre may need to keep your passport and documents while they process your application.

You must not travel outside of the UK, Ireland, the Channel Islands or the Isle of Man until you get a decision. Your application will be withdrawn if you do.



Information for EU/EEA nationals*

*This information is only applicable to EU, EEA or Swiss passport holders.

If you are an EU/EEA national, and have a **current EU, EEA or Swiss passport**, you will be taken through a number of screens to identify if you can use the free **UK Immigration**: **ID Check app** to scan your passport with a biometric chip and upload a photo of yourself. If you are able to use the app then you'll complete your entire application online. If you cannot use the app then you'll need to go to attend an in-person appointment after you apply. Your visa will be granted as a 'Digital Status' and you'll receive an email confirmation once the application is successful.

If you don't have a compatible phone, you can ask a friend or family member and can use their device to complete the ID check using the app. The app does not store/save any personal information and simply a mean to complete the biometric ID check.

If you can use the app then please click 'Continue' to proceed with your application.

If you do not have access to a compatible phone or cannot use the app then please click the links available and you will be directed to the standard old version of the application form.

Please note that this guide only covers the application process when using the ID check app. If you are not able to use the app and are completing a standard version of the application, you should still be able to use this guide for assistance on the questions in the application as the visa application questions would more or less be the same. The order in which they appear and how they are phrased may differ slightly.


Using the UK Immigration: ID Check app

Please see Useful Guide & video to using ID App and follow detailed instructions on app:

- Download ID app
- Use the same document with biometric chip symbol as you did to create your UKVI account
- Connect app using QR code to your application
- Take picture of photo page in passport ensuring you include entire page
- Scan passport or BRP to find biometric chip using app on your phone
- Scan face if aged 10 or over
- Take photo of yourself
- Once you have confirmed identity, you can complete the rest of the application on that device or any PC, laptop, table, smartphone.

If you cannot use the app, you will need to confirm your identity and apply using standard version of the application. You will also need to attend an appointment to have your fingerprints and photo taken after you apply. You should still be able to use this guide for assistance on the questions in the application as the visa application questions would more or less be the same.



STEP 5: Complete the visa application form

Doctorate Extension Scheme

Answer "No" if you have not previously been granted permission under the Doctorate Extension Scheme.

The Doctorate Extension Scheme is a type of visa which closed to new applicants in June 2021. You cannot apply for the Graduate Route visa if you have ever been granted permission under the Doctorate Extension Scheme.

Your identity card

An identity card is an official document issued by your country of nationality that can be used to prove your identity. Social security cards and driving licences are not considered ID cards for this purpose. You do not need to enter your passport details here.

It is likely that your current Tier 4 / Student visa is in the form of a biometric residence permit, unless you are an EU / EEA national that applied using the ID Check app.

If you have ever had a biometric residence permit for the UK, select "Yes" to this question. If you are able to, you should then provide details of your biometric residence permit in the next section or provide the reason why you cannot provide this. You will usually not need to provide your physical BRP card with your application, unless you have to attend a UKVCAS appointment or have not been able to use the ID Check app.


